DIRECTIONS FOR USE

Top dress **Harvest Pro 0-0-22** around the trunk of the tree making sure not to apply over the top or too near the trunk

Irrigate immediately after application. Apply enough water to ensure thorough coverage.

Harvest Pro 0-0-22 will provide 1 to 2 months of nutritional Potassium, Calcium and Magnesium to your fruit trees

More best results, follow-up granular treatment with a foliar liquid nutritional application of **La Bomba™**

Apply fertilizer in accordance with best management practices established by your State University or Cooperative Extension Service. Observe any State or Local fertilizer regulations pertaining to fertilizer content, application rates, or timing of application specific to your locale

Apply Harvest Pro at rate

Tree Age	Lbs. (per tree)
1yr	4 to 8 tablespoons
2yrs	½ to ¾ lbs.
3yrs	1 to 2 lbs.

- Repeat every 1 to 2 months during fruit set
- Once harvest is complete change over to **Fruit Special 8-3-9** for post-harvest recovery.
